Although these authors are naturalists, their findings support a sharp distinction between humans and animals all across the board of cognition. Well documented and persuasive.

Mind and Cosmos, Thomas Nagel, Oxford University Press; 1st edition, 2012 Again, although he is a naturalists, Nagel actually argues our side of the issue.

Again, Anderson is a naturalist, but he demonstrates convincingly that all the claims to talking apes are fraud and have no backing. We are all alone in our use of syntactical language.
